FTA INTO FORCE


The Free Trade Agreement between Switzerland and China has entered into force on July 1st, 2014.

On July 1st, 2014, sim participated in the celebrations of the entry into force of the Free Trade Agreement between China and Switzerland, in presence of H.E. State Secretary Marie-Gabrielle INEICHEN-FLEISCH, the Ambassador of Switzerland to China H.E. Jean-Jacques DE DARDEL and H.E. ZHONG Shan

Switzerland to China H.E. Jean-Jacques DE DARDEL and H.E. ZHONG S Vice Minister of Commerce in China.

The Agreement has been finalized during the Summer 2013 after 4 years of negotiations and will bring many reductions and/or eliminations of custom tariffs in both directions.

It will facilitate the market access for the Swiss exporters, being SMEs or bigger companies. Customs duties will progressively decrease in most areas of bilateral trade.



Furthermore, the legal framework will offer a better protection for intellectual property rights and investments.

A new chapter in Sino-Swiss relations
